

**Adventures Sports Club Clinics
Fundacion Real Madrid
Terms and Conditions**

1. Registration, Deposits fees and Cancellation Arrangements

A deposit of 50% of clinic fee is necessary for the sole purpose of registration for the clinic, payable on or before April 30th 2019. The remaining 50% shall be payable on or before June 30 2019. Clinic Fee is for direct payment to Real Madrid Foundation and for other clinic costs such as equipment and insurance among others therefore the clinic fee is non-refundable and non-transferable to another Adventures Sports Club Event. Cancellation can be voluntary or involuntary before or during the clinic however Adventures Sports Club will not incur any refund.

2. Unforeseen Event

Adventures Sports Club may cancel the clinic due to unforeseen events which shall include circumstances beyond the control of **Adventures Sports Club**, including but not limited to: war, threat of war, political crisis, civil commotion or strife, terrorist activity, strike or industrial action, natural disaster, fire, technical problems and due to closure of airports or other transport problems making it impossible or unreasonable to travel. Physical injury of participant prior to date of attendance is not an unforeseen event. **Adventures Sports Club** will not be responsible for any loss incurred by participant as a result thereof. In any such events as abovementioned; all fees already paid to Adventures Sports Club will be considered non-refundable.

3. Exclusion

Adventures Sports Club reserves the right to exclude or refuse participation of any person at any time to any clinic or activity of the clinic if, in the opinion of **Adventures Sports Club**, that person is not compatible with the general enjoyment or wellbeing of others at the clinic or the clinic surroundings. No refund will be given for any unexpired portion of the clinic or activity. All expenses for this exclusion will be the responsibility of the parent's participant.

4. Property Damages

Adventures Sports Club will vehemently pursue any (participant/person) damaging or defacing property while at the Clinic and strong action will be taken against such (participant/person). Payments will be sought in full from any such participant (or responsible parents) BEFORE departure to repair such damage. **Adventures Sports Club** reserves the right to expel any participant/person from its (clinics or activities) if there is willful damage to property, theft of property or act of vandalism.

5. Forbidden Items

Items such as Alcohol, prohibited, drugs, tobacco and weapons of any kind are strictly forbidden during the clinic. Adventures Sports Club reserves the right to remove any person and or participant from the clinic grounds and to refuse further access to the clinic if found to be in violation.

6. Medical Expenses and Information

All medical expenses incurred by the participant will be charge to the parent or guardian on file if their insurance coverage is denied and the amount is beyond your insurance coverage. Medical receipt will be given to the participant when he leaves the clinic. If a participant is under medical treatment during the clinic, it is strongly recommended to send with your registration a copy of the treatment being followed by the participant (it is MANDATORY in this case to get a medical certificate from your doctor in regards to the participant condition and is ability to participate in football and social activities). If the participant takes special medications, he must give them to the coaches. It is mandatory to mention all allergies on the Registration form. Adventures Sports Club reserves the right to exclude participation to the day's activity if coaches or medical personnel at the camp determine it is in the best interest of the participant.

7. Clothing (kit) and Equipment

All participants must wear kits purchased from Adventures Sports Club which shall either be **ADIDAS KIT:**

Official Real Madrid kit or Adidas kit, NOT official Real Madrid or White label kit
Only Football shoes are allowed.

8. Loss and Theft

During the clinic, each participant is responsible of his own personal clothes and equipment. **Adventures Sports Club** declines all responsibilities in case of theft, loss or damage.

9. Valuable Objects

It is strongly recommended not to bring valuables like jewelry, iPod, electronic games, cameras, computer laptops, etc. If participants chose not to aide with this rule, the coaches have the authority to prevent participants from participating in activities, since such items may cause distraction to other participants.

10. Participant Leaving Premises and Parents on Campus

It is forbidden to leave the clinic perimeter at all times. Parents are allowed on campus during the session under certain circumstances only.

11. Camp Staff

The clinic and facility will be managed by the director along with monitors who have full power for disciplinary actions. Participants must respect all (clinic) personnel.

12. Participant Discipline

Participants must respect the other participants and clinic staff. Participants must follow the daily planning of the clinic.

13. Camp Hygiene and Security

All participants at **Adventures Sports Club clinic** must respect and enforce the terms mentioned above. Such terms can be modified by **Adventures Sports Club** at any time.

14. Sufficient Number of Participants

The Organizer shall be entitled exceptionally to cancel your reservation should there be an insufficient number of participants for the session. In such event, the Organizer will inform you no later than one month before your clinic starts. In such event, **Adventures Sports Club** will not incur any refund but will propose another clinic.

Code of Behavior

- Play by the rules.
- Never argue with an official. If you disagree, have your captain, coach or manager approach the official during a break or after the competition.
- Control your temper. Verbal abuse of officials and sledging other players, deliberating distracting or provoking an opponent are not acceptable or permitted behaviors in any sport.
- Work equally hard for yourself and / or your team. Your team's performance will benefit, so will you.
- Be a good sport. Applaud all good plays whether they are made by your team or the opposition.
- Treat all participants in your sport as you like to be treated. Do not bully or take unfair advantage of another competitor.
- Cooperate with your coach, team mates and opponents. Without them there would be no competition.
- Participate for your own enjoyment and benefit, not just to please parents and coaches.
- Respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion.

IF THE CODE IS BREACHED AT TRAINING THE FOLLOWING WILL HAPPEN.

- First offence – Warning from Coach.
- Repeat offence – Sent off the field for time out.
- Serious breach – Expelled from that days training, caregivers are notified of the incident (If player is less than 18 years). The club management committee will then consider appropriate disciplinary action.

Privacy and Information Security Statement

The **Adventures Sports Club** online and paper-based registration process requires you to provide an array of personal information e.g. name, birth dates, addresses etc. This information is required for registration, membership & volunteer purposes with the **Adventures Sports Club** (the club).

Full names and phone numbers etc. will be used on **Adventures Sports Club** Team Lists etc. & may be used on the Club website and newsletters where appropriate or necessary, e.g. Rep Player or Player of the Year etc. The **Adventures Sports Club** will not make any identifying information available to any other parties without consent unless required in the ordinary operation of the Club.

Only members of the club executive will have access to your full registration information.

GUARDIAN'S RELEASE OF LIABILITY AGREEMENT & CONSENT

In consideration of allowing the minor to participate in any way, and at any time, in an event or activity, including sporting events, by **Adventures Sports Club**, or its related groups, the undersigned, on his/her behalf and the minor's behalf:

In consideration of being allowed to participate in any way, and at any time, in an event or activity, including sporting events, by **Adventures Sports Club**, or its related groups, the undersigned:

- 1) Acknowledges, appreciates, agrees, and fully understands that although particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist.
- 2) Acknowledges, appreciates, agrees, and fully understands that the significant risk of injury, including the potential for permanent paralysis and death, and severe social and economic losses which might result not only from their own action, inactions or negligence, but the actions, inactions or negligence of others from the activities, the rules of play, or the condition of the premises or of any equipment used involved in this program. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
- 3) Agrees that prior to participating, I will inspect the facilities and equipment to be used, and if I believe anything is unsafe, will immediately advise the event organizers of such condition(s) and refuse to participate.
- 4) Agrees to comply with the stated and customary terms and conditions for participation.
- 5) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE, WAIVE, INDEMNIFY, DISCHARGE, COVENANT, AND HOLD HARMLESS Adventures Sports Club**, its organizers, directors, commissioners, referees, officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, related groups and affiliated organizations, and owners and lessors of facilities used to conduct the event (Releases), from any and all liability with respect to any and all claims, demands, losses or damages on account of disability or injury, including death or damage to property, caused or alleged to be caused, in whole or in part, by the negligence of **Adventures Sports Club** or its related "releases" enumerated above or otherwise, to the fullest extent permitted by law.

6) Whenever possible each provision, term and covenant of this Agreement will be interpreted in a manner to be effective and valid but if any provision, term or covenant of this Agreement is held to be prohibited or invalid by a court of competent jurisdiction, then such provision, term or covenant will be ineffective only to the extent of such prohibition or invalidity, without invalidating or affecting in any manner whatsoever the remainder of such provision, term or covenant or the remaining provisions, terms or covenants of this Agreement.

7) In the event of any dispute between the parties which arises under this Agreement, such dispute shall be settled by arbitration, and not by a lawsuit or resort to court process except as Belize law provides for judicial review of arbitration proceedings. A list of arbitrators shall be presented to the Claimant and Respondent from which one will be chosen using the applicable rules. The hearing shall be conducted in the Judicial District, unless both parties consent to a different location. The decision of the arbitrator shall be final and binding upon all Parties. Each party shall be responsible for its own attorney's fees and its share of the arbitration fees. In the event a party fails to proceed with arbitration or fails to comply with the arbitrator's award, the other party is entitled to costs of suit, including a reasonable attorney's fee for having to compel arbitration or enforce the award. Any questions involving contract interpretation shall use the laws of Belize. An arbitrator's decision may be entered in any jurisdiction in which the party has assets in order to collect any amounts due hereunder.

8) Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability or death. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full **responsibility for my child participation.**

9) Photo & Image Release: I give my consent to have the minor's picture, image, and name to be printed in any **Adventures Sports Club** program, publication, or video.

10) Loss of Personal Possessions: I assume the risk of the personal possessions that I bring to all **Adventures Sports Club** events or its related groups events. I agree to release, waive, indemnify, discharge, and hold harmless **Adventures Sports Club**, its administrators, or related groups for any lost items. **Adventures Sports Club** does not have its own lost and found, but players are advised to contact the club to inquire if lost items have been reported. Players are advised to contact **Adventures Sports Club** to inquire about lost and found items.

This is to certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree to his/her release as provided above of all the Releases, and, for myself, my heirs, assigns, and next of kin, I release and agree to indemnify and hold harmless the Releases from any and all liabilities incident to my minor child's involvement or participation in these programs as provided above, even if arising from the negligence of **Adventures Sports Club** and the releases, to the fullest extent permitted by law. The minimum age for participation in Real Madrid Foundation Clinic Belize is seven (7) years of age and the maximum age is seventeen (17).

I also give my consent and approval for my minor child's picture and name to be printed in any **Adventures Sports Club** program, publication, or video.
